NOTIFICATION OF FORWARD AIR CONTROL EXERCISES

- The Ministry of Defence carries out Forward Air Control Exercises (known as FACEx) in a number or areas within the United 1 Kingdom. During these exercises, a Forward Air Controller, from a forward position on the ground or in the air, directs the action of combat aircraft engaged in close air support of land forces.
- 2 These training exercises will involve one or more fast-jet aircraft which will conduct simulated attack profiles against ground targets within a 5nm radius of one of the locations in Table 1 and as depicted on the attached Chart. Activity will involve dynamic lateral and vertical manoeuvring of aircraft at speeds of up to 450 knots IAS. Whilst engaged in training the aircraft may operate outside the 5nm radius and aircraft may not be able to comply with Rules of the Air and Air Traffic Services (RAC).

3 Each activity will be subject to NOTAM (see template below) to notify of the time and vertical extent of the exercise area. Each NOTAM will also contain a telephone number of the ground operators and a UHF and VHF frequency on which information on the participating aircrafts' positions and/or levels can be tactically obtained. Whilst no Air Traffic or Flight Information Services will be available from the Forward Air Controller, pilots intending to transit the activity areas are advised to establish


