## EDINBURGH AIRPORT APRON AND MANOEUVRING AREA DEVELOPMENT

### 1 Introduction

- 1.1 Edinburgh Airport will undertake an apron and manoeuvring area development programme between **January and July 2017**. This work will require stand closures, temporary stand changes, taxiway restrictions and taxiway closures.
- 1.2 Work will be undertaken in a phased approach as described in this AIP Supplement. The effective dates for each phase will be promulgated by NOTAM.
- 1.3 Any other work undertaken will be promulgated by NOTAM.

### 2 Main Apron/Taxiways E and F (10 Jan to 29 May 2017)


- 2.1 The Main Apron work involves changes to stands 2-4 and taxiway rehabilitation. During the work Taxiway E will be diverted to the west of its current centre-line. Stands 101-108 will be closed to form part of the diverted taxiway.

- 2.2 The following taxiway changes will be in force for the full duration of the work (10 Jan to 29 May 2017):

- Taxiway E restricted to maximum aircraft size B757-200W (41.1 m wingspan);
- Taxiway E will be closed at night (2330-0530);
- Holding Point F2 restricted to maximum Code C aircraft (except when taxiing between E1 and F2, which is restricted to maximum aircraft size B757-200W);
- Holding Point E1 stop bar disabled.

#### 2.3 Main Apron Phase One (10 Jan to 24 Feb 2017)


- 2.3.1 Stands 3A, 4, 4A, 5 and 105-108 closed. Work will take place on stand 4/4A and on Taxiway E immediately west of Stand 4;
- 2.3.2 Taxiway E diverted across stands 105-108 to E1.



2.4 **Main Apron Phase Two (24 Feb to 12 Apr 2017)**

2.4.1 Stands 2A, 3, 3A, 4 and 103-108 closed. Work will take place on stand 3/3A and on Taxiway E immediately west of Stand 3;


2.4.2 Taxiway E diverted across stands 103-108 to E1.



2.5 **Main Apron Phase Three (12 Apr to 29 May 2017)**

2.5.1 Stands 2, 2A, 3 and 101-108 closed;

2.5.2 Taxiway E diverted across stands 101-108 to E1



**3 Southeast Apron / Taxiway G and Taxiway L (10 Jan to 24 May 2017)**


3.1 To allow the construction of additional stands and rehabilitation of Taxiway L, Taxiway G will initially be restricted and then closed completely. Taxiway L will be closed;

3.2 During the work, the following stand changes will be in force:


- Stand 16 closed;
- Realigned Stand 17 available to maximum Code D aircraft plus A332/B788. No stand guidance available (marshalling required);
- New temporary stand 17A to south of closed Stand 16. No stand guidance available (marshalling required);
- Stand 18 closed;
- Realigned Stand 19 available for maximum Code C aircraft. No stand guidance available (marshalling required).

3.2.1 **Southeast Apron Phase One A (10 Jan to 30 Jan 2017)**

- 3.2.1.1 Twaxiway G restricted to Code C aircraft only (Code D aircraft require escort by 'follow me' vehicle).
- 3.2.2 **Southeast Apron Phase One B (30 Jan to 27 Apr 2017)**
- 3.2.2.1 Taxiway G restricted to Code C aircraft only (Code D aircraft require escort by 'follow me' vehicle);
- 3.2.2.2 Taxiway L closed;
- 3.2.2.3 Aircraft access to/from Southeast Apron, South Cargo Apron, Stands 50-54 and General Aviation parking areas may require routing via Taxiway P and Taxiway Q;
- 3.2.2.4 Code E aircraft access to/from the Southeast Apron will be via Taxiway H and require will escort by 'follow me' vehicle between H1 and Stand 25.




- 3.2.3 **Southeast Apron Phase Two (24 Feb to 24 Mar 2017)**
- 3.2.3.1 Taxiway G closed;
- 3.2.3.2 Taxiway L closed;
- 3.2.3.3 Aircraft access to/from the Southeast Apron will be via Taxiway H only;
- 3.2.3.4 Aircraft access to/from Southeast Apron, South Cargo Apron, Stands 50-54 and General Aviation parking areas may require routing via Taxiway P and Taxiway Q;
- 3.2.3.5 Code E aircraft access to/from the Southeast Apron will be via Taxiway H and will require escort by 'follow me' vehicle between H1 and Stand 25.



### 3.2.4 Southeast Apron Phase Three (24 Mar to 24 May 2017)

3.2.4.1 Stand construction work will continue but Taxiway G and Taxiway L will be open.



## 4 Taxiway Fillets at A1 and D1 (23 Jan to 10 Mar 2017)

4.1 Work will be undertaken at night (2330-0530) to construct taxiway fillets between A1 and A3 and D1 and D3.

### 4.2 Taxiway Fillet A1-A3 (16 Feb to 10 Mar 2017)

4.2.1 Between 2330 and 0530, Taxiway A will be closed to aircraft between A1 and A8.

### 4.3 Taxiway Fillet D1-D3 (23 Jan to 15 Feb 2017)

4.3.1 Between 2330 and 0530, Taxiways A and D will be closed to aircraft between A18 and D1.
